Instructions: These specimens are extremely fragile and should not be handled any more than is necessary. The specimens must not be altered in any way. Specimens must be maintained in airtight cases protected from insect pests, water damage, and excess light. Relative humidity must be maintained between 45% and 65%. A stable temperature must be maintained between 65 and 72 degrees F. Permission must be granted by the Museum of Comparative Zoology for use of these specimens in photographs. Contact the Bird Department and/or the Museum of Comparative Zoology for permission. Grantees must acknowledge the "Ornithology Department, Museum of Comparative Zoology" in all publications that use MCZ specimens. Publications should include a table that lists voucher numbers of all specimens used. Credit lines for the labels and other publicized information should read "Ornithology Department, Museum of Comparative Zoology."

## TERMS AND CONDITIONS:

- 1. Specimens from the collections of the Museum of Comparative Zoology are loaned at the discretion of the museum.
- 2. Specimens are loaned to bona fide institutions, not to individuals.
- Borrowing institutions must demonstrate that they have the ability properly unpack, care for, use, and return the borrowed specimens before a loan is granted.
- 4. The specimens must be returned by the date stated on the involce unless a loan renewal is granted in writing by the loaning department.
- 5. Specimens on loan must be cared for according to standard best practices of collection care and handling.
- 6. Loans may not be transferred to another institution without the express written permission of the curator of the loaning department.
- 7. No invasive procedures (e.g., penetrations of the body wall or removal of any parts) of a loaned specimen may be conducted without the express written permission of the curator of the loaning department.
- 8. Express written permission must be obtained before a loaned specimen, image, mold or cast of the specimen may be used for any purpose other than scholarly research.
- Loaned specimens must be packed for return in accordance with professional standards and be legally shipped to the Museum of Comparative Zoology.
- 10. A loan may be recalled by the Museum of Comparative Zoology at any time at the discretion of the curator of the lending department or the Director of the MCZ.
- 11. Copies of all publications, reports, or other citations of the loaned specimens must be sent promptly to the Museum of Comparative Zoology.
